## MEMORANDUM OF UNDERSTANDING

BETWEEN

Represented by its President, Prof. Dr. Ir. Akhmad Fauzi, MMT.,IPU.

HCMCOU and UPNJT shall collectively be referred to as the "**Parties**" and individually as the "**Party**".

### THE TWO PARTIES AGREE ON THE FOLLOWING:

#### Article 1: Purpose of the agreement

This cooperation agreement aims to promote the capabilities and strengths of each party, effectively exploit and utilize the potentials of facilities, people and expertise in training high-quality human resources to meet the practical needs of social organizations.

Coordinate to improve the professional training program for students in the fields of training of Parties.

This cooperation agreement will bring practical benefits to both sides in the field of practical training and developing high quality human resources.

#### Article 2: Areas of collaboration

The parties signing this memorandum agree to encourage collaborative activities and to promote a partnership in terms of:



- Introducing and sponsoring student projects and internships program in Southeast Asian Studies and other majors.
- Implementing R&D projects either jointly between the HCMCOU and UPNJT members or by HCMCOU with the request from MCE members.
- Other collaboration activities that suitable for Parties.

**Article 3: Agreement Principles**

This MoU is intended to be a summary of the current intentions and understandings of the Parties with respect to the areas of collaboration. This MoU is not intended to, and does not, constitute a legally binding obligation or an agreement to enter into any financial or other arrangement or any agreement.

**Article 4: Duration and termination**

This agreement will be valid for Two (2) years from the time it is signed by the authorized representatives of the two parties. It can be terminated at the initiative of either party provided that an advance notice of six months at least be sent to the other party. In either case, all ongoing projects will continue as agreed per project.

**Article 5: Disagreement**

In case of difficulties in interpreting or applying this agreement, an amicable resolution of the problem will be sought as soon as possible.

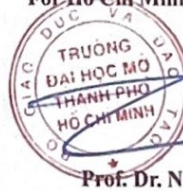
