Akhmad Fauzi, M.M.T., IPU., a rector, is a higher education institution in Indonesia originally established in 1959 and was declared as a state-owned university in terms of the Presidential Regulation of Indonesia Number 122 Year 2014 located at Jl. Raya Rungkut Madya, Gunung Anyar, Surabaya, Indonesia 60294 (hereinafter referred to as "UPNVJT"), and shall include its lawful representatives and permitted assigns,

and

ASIA UNIVERSITY, TAIWAN represented by Prof. Jeffrey J. P. Tsai, as president, appointed under the board of trustees of Asia University, for and on behalf of Asia University of which the address is No. 500, Lioufeng Rd., Wufeng, Taichung City 41354, Taiwan (hereinafter referred to as "AU"), and shall include its lawful representatives and permitted assigns.

The purpose of this MOU is to express the Parties' intention for cooperation and does not constitute nor create, and will not give rise to any legally binding or enforceable obligations, either expressed or implied, under both domestic and international law. The Parties may enter separate formal, legally binding agreements in writing pertaining to their various joint activities, which will fully document the rights and obligations of each Party. The Parties hereby confirm their mutual understanding as follows:

ARTICLE 1 AREAS OF COLLABORATION AND COOPERATION

- (1) Within the context of their respective mandates, objectives and procedures, the collaboration between Parties will focus on the following areas:
 - a) academic cooperation,
 - b) research collaboration,
 - c) community services.
- (2) Any future cooperation will be considered, on a case-by-case basis, upon the merit of each case and within the limitations of the mandate and resources of each Party.

ARTICLE 2 CONFIDENTIALITY

The Parties shall be held accountable for the confidentiality of any information and/or data which are exchanged, acquired, and shared amongst the parties throughout the course of activities and/or any other projects conducted in accordance with this MOU, unless said data and/or information has already been registered in public domain prior to this MOU.

ARTICLE 3 NO AGENCY

Nothing contained herein is to be construed so as to constitute a joint venture partnership or formal business organisation of any kind between the Parties or so to constitute either Party as the agent of the other.
