This Memorandum of Understanding (here in after referred to as MoU) is signed at Universitas Pembangunan an Nasional "Veteran" Jawa Timur (UPNVJT) on this day, 26 April 2024, between Universitas Pembangunan Nasional "Veteran" Jawa Timur (UPNVJT), represented by Prof. Dr. Ir. H. Akhmad Fauzi, M.M.T., IPU., the Rector of UPNVJT, a public higher education institution established on 5 July 1959, located at Jl. Raya Rungkut Madya, Gunung Anyar, Surabaya, Indonesia 60294, and Songkhla Rajabhat University, represented by Associate Professor Dr. Tussana Sirichot, the President, whose address is 160, Moo 4, Tambon Khoa-Roob-Chang, Muang District, Songkhla 90000, Thailand (here in after referred to as "SKRU")

UPNVJT and SKRU seek to establish mutually academic collaborations, both Parties have agreed to sign this memorandum of understanding (MoU) as follows:

1. Field of collaboration

The collaboration between the parties will encompass research collaboration and the promotion of academic activities at the two institutions.

2. Areas of Collaboration and Support

2.1 The parties agree and acknowledge that collaboration may develop in the following areas, but is not limited to:

a) Collaboration on joint proposals for national and international funding agencies (e.g., AUN-SEED, LPDP, Asian Development Bank, Internal Funding of UPNVJT, etc.).

b) Exchange of information and materials related to academic activities of mutual interest.

c) Songkhla Rajabhat University shall prioritize UPNVJT lecturers for further postgraduate studies at Songkhla Rajabhat University, and UPNVJT shall give priority to Songkhla Rajabhat University lecturers for further postgraduate studies at UPNVJT.

d) Promotion and facilitation of the exchange of research and teaching staff, as well as students, for research student exchanges, staff exchanges, joint research, joint supervision, and joint research training.

e) Organization of international collaborations such as conferences, symposia, cultural and sports activities.

f) Other related fields as mutually agreed upon in the future.

2.2 For the purpose of implementing collaboration in respect of any areas stated in paragraph 2.1, where any activities may give rise to rights and obligations between the parties, a separate legally binding agreement shall be entered into for each activity, subject to the approval of both parties.

3. Duration and Termination

This MoU shall enter into force at the day of signature by the signatory of each party and shall remain in force for three (3) years unless terminated by one of the parties giving three (3) months written notice to the other.

This MoU may be extended for a further period as maybe agreed in writing by the parties. Where such termination occurs, the provision of the collaborative programs shall continue to apply to on-going activities until their completion.

The termination of this MoU shall not affect the continuation of activities, operations, or projects that have already commenced. If there are activities or projects that have not yet been completed, both parties shall collaborate to ensure their completion, in order to prevent any damage. Unless both parties agree otherwise.

The termination of this memorandum of understanding shall not give rise to any claims for expenses or damages against each other.

4. Confidentiality

Each party shall only use the other party's confidential information which is communicated to it in connection with this MoU for the purpose for which it was communicated or with the permission of the communicating party.

5. Intellectual property

Nothing in this MoU alters or affects the ownership of any intellectual property communicated by one party to another. To preserve intellectual property rights, any research findings and inventions arising from joint activities under this MoU shall constitute the intellectual property rights of both parties. The final disposition of these intellectual property rights will be subject to mutual agreement between both parties. Neither party will assert any claim on previously existing intellectual property owned by that respective party.

6. Cost and Expenses

Any cost and expenses incurred in performing any activity pursuant to the collaborative programs shall be negotiated to the mutual acceptance of both parties.

7. General

Each party will assign a person to be in charge of the implementation and maintenance including negotiation and management of this MoU.

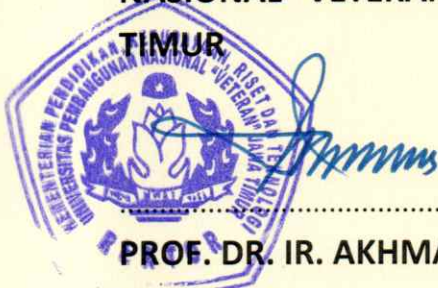

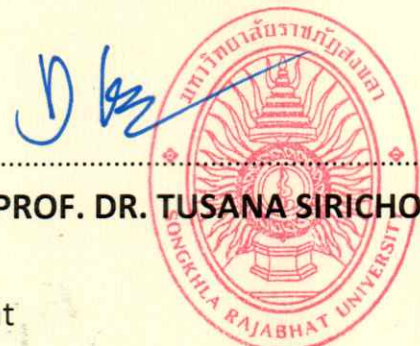
